
MNCLHD My Health Learning Mandatory Training Update

March 2021





NEW Mandatory Training Targeting

The Mandatory Training Standing Committee (MTSC) has endorsed the following **new mandatory training**:

• ims+ How to Notify an Incident (Course Code: 259009870)

ims+ How to Notify an Incident training will be state-wide targeted (red-flagged) from <u>19 March 2021</u>. The new ims+ How to Notify an Incident module was developed to replace the mandatory IIMS Notifier Training. **All staff must complete the new ims+ training**, regardless of their completion status against IIMS Notifier Training. Training is to be completed once-only and the duration is between 30-45 minutes. IIMS Notifier Training will no longer be available on My Health Learning after 19 March 2021. • COVID-19 Vaccination Training Program for Clinical staff - Learning Pathway

Only staff who have been selected and authorised in MNCLHD to administer or manage COVID-19 vaccines are required to complete the following *core* modules, targeted as at 3 March 2021:

- Vaccine Storage and Cold Chain Management (155487019)
 - National COVID-19 Vaccination Training Program
 - 1. COVID-19: An introduction (25 minutes)
 - 2. Handling and storage (40 minutes)
 - 3. Communication and purpose (40 minutes)
 - 4. Multi-dose vial (MDV) training and delivery (25 minutes)
 - 5. Documentation and reporting (25 minutes)
 - Safety surveillance and reporting of adverse events following immunisation (30 minutes)
 *Additional Modules:
 - Additional Module 1: PfizerBioNTech vaccine
 - Additional Module 2: Oxford/AstraZeneca vaccine

The training is accessible via <u>covid19vaccinationtraining.org.au</u> Completion Certificates are to be sent to <u>MNCLHD-NMW-EA@health.nsw.gov.au</u> and will be uploaded to My Health Learning as a priority.

Non-clinical staff working in vaccination clinics will be targeted in 'COVID-19 Vaccination Training program for Administrative and non-clinical staff'

MNCLHD Endorsed Training

Staff required to complete this training have already been assigned and can complete via their My Health Learning Current Learning profile.

• MNCLHD Immunisation Nurse Learning Pathway

This pathway has been assigned to all identified immunisation nurses within MNCLHD. This pathway incorporates the requirements of Basic Life Support, Vaccine storage and eMeds modules which are essential for staff working in with the Vaccination Program.

• MNCLHD Respiratory Protection Program

The MNCLHD Respiratory Protection Program is a long-term strategy which aims to protect staff from pathogens spread via airborne and droplet transmission routes. This pathway has been assigned to appropriate staff in the clinical setting.

It is recommended that staff complete the following training to maximise their protection:

- > MNCLHD Local Induction to PPE (donning and doffing competency)
- > 319438161 Donning and fit checking of P2 or N95 mask in NSW
- > 294450660 Personal protective equipment for combined transmission-based precautions
- > 46777047 Infection control prevention and control practices
- > 253093581 Infection control transmission-based precautions
